#### 1. Sawmills and Traders

This register lists the Primary/Secondary sawmills and traders.

A primary sawmill is one located near a forest concession. These sawmills process logs into squared and/or rough sawn timber prior to transportation to other locations for further processing. These sawmills have been established to comply with local government regulations that prohibit the transportation of raw timber from West Papua province to other provinces in Indonesia.

A secondary sawmill is one that processes timber into finished product. These mills may utilize processed timber from primary sawmills in West Papua or raw timber from forest concessions outside of West Papua.

A trader is a third party that involved in supply chain that accommodate sawmills mostly with raw materials (logs/round wood) supplies.

## 3. Status

Current status of certification or assessment of the sawmill The status is colour coded:

- Green indicates that the sawmill and trader certification is valid and acceptable.
- Yellow indicates that the sawmill and trader certificate is in the process of being extended. Certificates can be accepted.
- Red indicates that the sawmill and trader certificate has expired, is suspend or on hold.
   CertiSource claims for each products group shipped whilst a certificate is suspended or on hold should not be accepted.

### 2. CoC Certificate No.

Sawmills and traders undergo a comprehensive Chain-of-Custody (CoC) audit every three years for re-certification process.

On successful completion of the audit a CoC certificate is issued with a unique reference number.

Note that the certificate reference number format is been changed to CS-DX-12345-ABC-SS or PS or LT.
